GENERAL MANAGER'S REPORT

"Technology Happens Here"

Rapid technological changes today affect every aspect of our lives, whether we are at home, work or play. For SRT, rapid technology changes mean networks that typically used to last 25 years, now can become outdated in a matter of a few years. Today we must invest millions of dollars into our networks each year to keep up with the current demands of our customers created by this new technology.

Fiber Optics

In order for us to provide a broadband Internet network that allows us to provide the latest advanced services customers now demand, we have committed to upgrading our cable plant with Fiber Optics. Fiber is widely considered to be the premier means for providing the fastest broadband Internet speeds to customers as well as the clearest voice service.

The fiber project was adopted in 2012 by the board of directors and we've made significant progress. Last year, we completed the fiber build-out in rural Berthold, Mohall, Deering, Sawyer and Velva. We are well into the construction phase for rural Towner, Karlsruhe, South Prairie, Donnybrook and Surrey. We are just approving the construction contracts to start building out rural Des Lacs, Sherwood, Glenburn, Butte and Antler.

We also continue to see major business and housing development growth throughout our service area. All new construction is done with Fiber Optics.

Advanced Services

These network changes are exciting in that they allow us to offer the latest advanced services including:

FiberNet, High-speed Internet

Perhaps you're still on the same speed from a few years ago, but you probably have changed how you use the Internet. FiberNet allows you to get the fastest uploads and downloads.

2013 in Review

New Regulation: FCC Broadband Order

The rural industry as a whole continues to deal with the changes imposed by the FCC Broadband Order. Unfortunately, the FCC has adopted a Universal Service Order which inadequately supports the broadband and high-speed technology extensions they supposedly envision for the entire nation, including rural areas.

The order also implemented regulatory requirements affecting intercarrier compensation (how communications carriers compensate each other for use of networks), resulting in less revenue for rural

companies while placing more of the financial burden on rural customers.

SRT is working with NTCA -The Rural Broadband Association to deliver the core message to Washington, DC Legislators that changes to Universal Service are placing an unfair burden on customers.

Our North Dakota Delegation has shown strong interest and support in the efforts of SRT (in concert with all the North Dakota rural companies) and NTCA to get aspects of the plan reconsidered.

Financial

The financial statements show that SRT's equity ratio remains strong at 68%. In fact, the 2013 patronage margin to members was just under \$3 million. However, our margins are feeling the effects of the FCC Broadband order that were discussed earlier. As a result, that means less revenue for rural companies.

SRT also received approval from RUS and our auditors to do a one-time write-off of the remaining goodwill from the Minot Purchase back in 1994. The write-off was done in a manner that did not involve patronage capital equity and accordingly, did not impact any individual patronage accounts.

2014 Plans

SRT has reinvested \$120 million back into the network since 2007 to keep up with new technology. For 2014, the capital budget rose to almost \$35 million.

The investment to place fiber and roll out advanced services throughout the SRT territory is high. It requires us to commit all of our internal cash

resources, along with our two RUS-approved loans, to accomplish this goal.

As a result, the SRT Board of Directors has chosen not to do a general retirement of capital credits until the fiber projects are complete. SRT will continue to retire Estate Capital Credits during this period.

SRT: Company in Transition

3. Unprecedented Growth and New Construction

Fortunately, SRT is well-positioned to handle the transition in a manner that allows us to provide high quality communications services which are responsive to the needs of our customers today and well into the future.

Thank you members, Board of Directors, and employees for your support of SRT's technology-driven transition.

This past year we invested over \$20MM in new equipment to serve all the new businesses, homes and apartments

We are well into our plan to replace our copper connections with fiber optic technology, which will allow us to deliver voice, data, and television at not only first class speeds but also at the highest quality.

MINUTES OF THE 2013 ANNUAL MEETING

The 62nd Annual Meeting of the members of SRT Communications, Inc. (SRT) was held at the North Dakota State Fair Center in Minot, North Dakota, on Thursday, June 20, 2013, pursuant to due notice to all members. President Tom Wentz, Jr., presided.

NATIONAL ANTHEM/FLAG PRESENTATION: President Tom Wentz, Jr., asked all members to rise for the National Anthem. Presentation of the flags was done by Boy Scouts of America Troop 411, sponsored by the Moose Lodge. Marsha DesLauriers, sang the National Anthem.

WELCOME: President Tom Wentz, Jr., welcomed everyone to SRT's 62nd Annual Meeting.

INVOCATION: SRT Public Relations Coordinator Jackie Rostad provided an invocation.

INTRODUCTION OF SRT BOARD MEMBERS: President Tom Wentz, Jr., took a few moments to introduce SRT's current board members.

INTRODUCTION OF GUESTS & READING OF LETTERS: President Tom Wentz, Jr., read the names of special guests and letters of dignitaries, including: Senator John Hoeven, Senator Heidi Heitkamp, Representative Kevin Cramer, and Public Service Commissioner Randy Christmann.

CALL TO ORDER: The meeting was called to order by President Tom Wentz, Jr., at 7:22 p.m. The President declared the presence of a quorum. President Tom Wentz, Jr., appointed Attorney David Hogue as recording secretary and parliamentarian.

READING OF ANNUAL MEETING NOTICE: SRT Secretary Susan Schmutzler read the official notice of meeting and proof of mailing.

READING OF 2012 ANNUAL MEETING MINUTES: It was moved, seconded, and carried to approve the minutes of the

2012 annual meeting of members as printed on pages 15-16 of the 2013 annual meeting booklet, and to dispense with oral reading of the minutes.

NOMINATIONS PROCEDURE & INTRODUCTION OF CANDIDATES:

Attorney David Hogue, from Pringle & Herigstad, PC explained the procedure for nomination and election of directors of SRT, who are responsible for the management of the cooperative's business and affairs. Attorney Hogue introduced the candidates from each district: Allan Engh, of Sherwood (District 1), Jim Newman of Sawyer (District 2), Gerald Henry of Newburg (District 3) and Tom Wentz, Jr., of Minot (District 4).

CREDENTIALS AND ELECTION COMMITTEE: President Tom Wentz, Jr., announced that members Lynn Beckedahl from Sherwood, Sandie Thomas from Velva, Matt Marsh from Newburg, and Duane Brekke from Minot were appointed as the Credentials and Election Committee.

SCHOLARSHIP RECIPIENTS: President Tom Wentz, Jr., explained SRT's scholarship program and named the 2013 recipients. They are: Ashley Backes, Minot High School; Lindsey Mogard, Surrey High School; Ahnna Peterson, Velva High School; and Shelby Wunderlich, Velva High School. Ms. Backes addressed the members about her career plans. She thanked SRT for awarding her the scholarship.

YOUTH TOUR RECIPIENTS: President Tom Wentz, Jr. also announced the student chosen to represent SRT at the 2013 Foundation for Rural Service Youth Tour Program held in Washington, D.C. Cassidy Peterson from Velva High School was this year's representative.

FINANCIAL REPORT: President Tom Wentz, Jr., introduced Perry Erdmann, the Chief Financial Officer of SRT. Mr. Erdmann described the financial results for the past fiscal year and the results of an independent audit of SRT's consolidated operations. Mr. Erdmann reported SRT earned revenues of

\$50.73 million and incurred expenses of \$46.56 million. SRT's "net margin," the rough equivalent of net profit was \$5.73 million for 2012.

MESSAGE TO OUR MEMBERS REPORT: General Manager Steve Lysne presented the Cooperative's "Message to Our Members" report. Mr. Lysne described SRT's completion of rebuilding damaged infrastructure from the June 2011 flood. He described how SRT is responding to the challenges created by unprecedented growth in Minot. Mr. Lysne explained the deployment of fiber in the rural districts of SRT. Mr. Lysne reviewed SRT's rollout of the Apple "iPhone".

PRESIDENT'S MESSAGE: President Tom Wentz, Jr., reminded members that they are both the customer and owner of SRT. He described the advantages of the cooperative business model over for profit telephone companies. Mr. Wentz noted SRT is motivated to provide great service to all SRT's member/customers because each member has an equal vote.


OTHER BUSINESS: The President called for old and new business. [None presented.]

DOOR PRIZES: Following formal adjournment of the meeting, several door prizes were awarded.


