#### **JOHN REISER RETIREMENT**

John Reiser, SRT Chief Operating Officer and Assistant General Manager, retired November 30th after 26 years with the organization.

John joined SRT as Controller in 1996, then progressed to Director of Accounting before becoming COO/Assistant General Manager in 2003. As COO he led



SRT through several pivotal milestones for the cooperative. While SRT was transitioning from a landline phone company to a broadband company, John oversaw day-to-day operations while managing key projects that helped SRT build its state-of-the-art fiber optic network. He also negotiated with national wireless carriers when SRT exited the retail wireless business in 2017, as well as ongoing tower lease agreements.

"We all hold John in high regard for his impressive knowledge of telecommunications, from policy and insurance to contracts and many other aspects of the industry," said Cassidy Hjelmstad, SRT Chief Executive Officer and General Manager. "His ability to view situations with the big picture in mind will be greatly missed."

A respected voice in the industry, Reiser served nationally on NTCA-The Rural Broadband Association's Retirement & Security Program and Savings Plan Trust Committee. His legal background and human resources expertise were assets to the national committee and an invaluable resource for SRT employees.

#### **PROCEDURE FOR THE NOMINATION OF DIRECTORS**

The purpose of the SRT Annual Meeting is to elect directors to the Board of Directors and hold a business meeting of the Cooperative. Directors are elected to serve a three-year term. SRT's twelve-member Board of Directors represents our service area throughout the year by attending monthly board meetings, serving on state associations, attending community events, and supporting SRT in the national telecommunications space. Beginning April 17, 2023, the following steps must be taken if you are interested in becoming a candidate for election as an SRT Director.

#### **PROCEDURE STEPS:**

- 1. A Nomination of Directors Petition Form indicating the director district must be obtained from SRT Headquarters (principal office of the Cooperative) located at 3615 North Broadway in Minot.
- 2. Fifteen (15) or more members from the same district from which the nomination is being made must sign the written petition. A married couple constitutes one membership. Either spouse may sign this petition as a member. However, the signature of married spouses on this petition may only be counted as one of the fifteen (15) members necessary to nominate a director.
- 3. All nominations by petition must be received at SRT Headquarters located at 3615 North Broadway in Minot no earlier than April 17, 2023, nor later than May 16, 2023, by 5:00 p.m. Petitions postmarked before May 16, 2023 but arriving by mail after May 16, 2023 cannot be accepted.
- 4. All nominations by petition are subject to verification of membership of signatories. Once verification is complete, the candidate will be notified and their name will appear on the ballot at SRT's Annual Meeting. Nominations for director candidates will not be accepted from the floor at the Annual Meeting.

#### **2022 SRT ANNUAL MEETING**



The 2022 SRT Annual Meeting was held Wednesday, October 12, 2022, at the North Dakota State Fair Center in Minot. Nominations of directors' petitions were distributed and accepted at SRT's headquarters from August 14, 2022, through September 13, 2022. Five petitions were qualified and verified, which authorized the names to be placed on the official election ballots that were distributed at the meeting.

Four directors were elected to serve a three-year term on SRT's Board of Directors: District 1: Allan Engh, Sherwood; District 2: Tom Jespersen, Velva; District 3: Stuart Rothe, Newburg; and District 4: Benjamin Robertson, Minot. Members also voted to approve the 2021 Annual Meeting Minutes as presented.

## OFFICIAL NOTICES

### 988 SUICIDE AND CRISIS LIFELINE: HELP IS ONLY THREE DIGITS AWAY.

"988" is the three-digit, nationwide phone number to connect directly to the 988 Suicide and Crisis Lifeline, formerly known as the National Suicide Prevention Lifeline. Simply calling or texting 988 will connect you to compassionate mental health professionals who can provide care and support, or help you support a friend in need.

### **AFFORDABLE CONNECTIVITY PROGRAM**

The Affordable Connectivity Program (ACP) is a federal program designed to assist low-income households in paying for broadband internet service. ACP is under the authority of the Federal Communications Commission (FCC) and is administered by USAC. ACP replaced the Emergency Broadband Benefit Program (EBBP).

Eligible households can receive up to a \$30 monthly discount on broadband internet service.

The ACP benefit is non-transferable and limited to one monthly internet discount per household. ACP is available for all service offerings (includes broadband internet access service or a bundle of broadband internet service along with voice telephone service). You may obtain ACP-supported broadband internet service from any participating provider of your choosing and may change providers at any time.

In the event the program ends or when a household is no longer eligible, customers will be subject to SRT's regular rates, terms, and conditions. You can get ACP if you (or someone in your household): (a) already receive a Lifeline Benefit; (b) received a Federal Pell Grant during the current award year; (c) participate in certain Federal Assistance Programs (National School Lunch Program, WIC, SNAP, Medicaid, Supplemental Security Income (SSI), Housing Choice Voucher (HCV) Program (Section 8 Vouchers), Project-Based Rental Assistance (PBRA)/202/811, Federal Public Housing Assistance, Veterans Pension and Survivors Benefit); or (d) if your household income is at or below 200% of the Federal Poverty Guidelines.

Apply for ACP with USAC at AffordableConnectivity.gov. After USAC determines you are eligible, call SRT to enroll in the ACP program.
